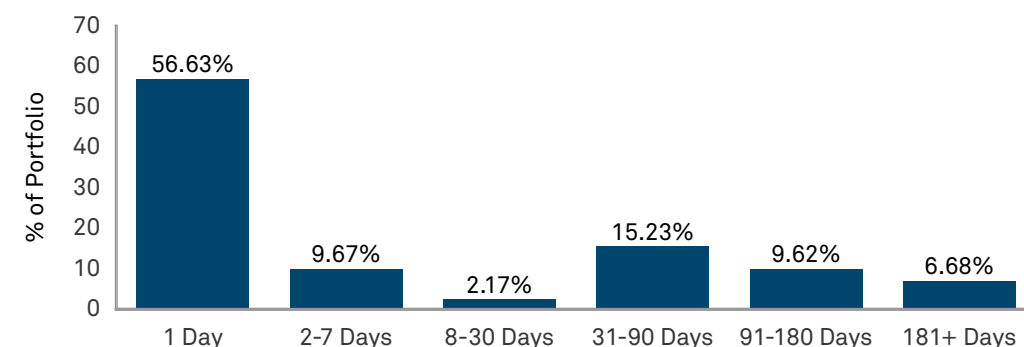

Fund Goal

The fund seeks as high a level of current income as is consistent with the preservation of capital and the maintenance of liquidity.

Investment Approach

The fund pursues its investment objective by investing only in government securities, repurchase agreements collateralized

solely by government securities and/or cash, and cash. The fund seeks to invest in securities that present minimal credit risk, based on Dreyfus assessment of the issuer's, guarantor's or counterparty's credit quality and capacity to meet its financial obligations, among other factors. The fund is a government money market fund managed to meet the requirements of Rule 2a-7 under the Investment Company Act of 1940, as amended.
