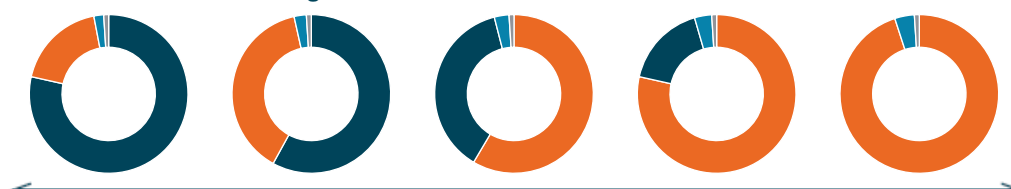

BNY Target Risk Portfolios performance data shown represents composite numbers calculated by BNY Advisors. Performance data is derived from accounts directly monitored by BNY Advisors, at such time as there are sufficient accounts to produce a meaningful statistical sampling.
