Federal Form 1099-DIV will be issued to you and Federal tax rules require the reporting of tax exempt income as a memo item on your individual income tax return.

If you redeemed any shares of the Fund acquired through the Dividend Reinvestment Plan during 2024, Federal tax rules require us to report the gross proceeds from such redemption to the Internal Revenue Service. Shareholders will receive notification of their respective proceeds early in 2025.

State and local taxes differ from state to state. It is suggested that you consult with your own tax advisor with respect to these taxes.

The table below shows the annual percentage breakdown, by state or U.S. possession, of the interest exempt from regular Federal income taxes, earned by the Fund for those states and possessions in which the Fund had investments during the year 2024.
