**This letter contains important information about your investment(s) in BNY Mellon Global Absolute Return Fund and/or BNY Mellon Global Multi-Strategy Fund (the Funds), sub-funds of BNY Mellon Investment Funds (BNY MIF).**

**BNY Mellon Fund Managers Limited (BNY MFM) is the authorised corporate director for this fund range.**

**No action is required from you.**

We, BNY MFM, regularly review our disclosures and products to ensure they remain appropriate.

We are updating the investment policies for the Funds to remove the 35% of assets investment limit in a single issuer of government and public securities and to enable the Funds to invest up to 100% of assets in government and other public securities. This is to allow greater flexibility for the investment manager, Insight Investment Management (Global) Limited, to achieve each Fund's investment objective.

The Funds have been managed in compliance with the limit to date and there will be no change to their risk profile.

The update to Funds' investment policies will take effect on or around 19 November 2025.

The FCA has confirmed all the updates and clarifications mentioned above do not affect the Funds' ongoing authorisation.
