Direct Indexing has been popular for a select group of investors for decades. But thanks to recent advances, its potential benefits are more widely available. Direct indexing (DI) is not a new concept, and many select investors have benefited from the investment approach for years. Historically, DI strategies were primarily available for high-net-worth investors whose large portfolios justified the costs and human resources required to manage portfolios in a customized manner. DI's recent rise in popularity is largely due to investment managers' ability to streamline and efficiently manage the process through technology at scale. This has resulted in lower operating costs, which has opened the door to more investors to explore direct indexing's potential benefits.
